1. Welcome from the Chair

2. Apologies for absence

3. Minutes of Previous Council

Laura Dean missed off the list of Student members attending. With this amendment, the minutes passed by ascension.

<u>Part A</u>

School of the Month Presentation – Chemistry were the winners for December. January's winner is Life Sciences, this will be presented in a few weeks.

4. Presidential Report

- Report taken as read.
- Yik Yak update Yik Yak is banned on University Internet Firewall.
 It was decided that the ban would not be publicised at the University's request. It was also to prevent negative comeback on members of council.
- Concerns were raised that this is not wholly effective as it can still be accessed on Mobile networks. As University students are over 18, we cannot have a complete network ban like Schools.
- Naming of the new Marina Courts will be discussed in Any Other Business.

5. Motion to 'Stand up for Student Survivors'

Speech For:

- Presented by Jessica Bartholomew. The content of this discussion could be upsetting. Members were invited to leave if they were uncomfortable.
- The University should reject the Zellick guidelines and create their own for Lincoln. Currently, the Zellick report recommendations do not protect vulnerable students.
- Concerns were raised that this could mean if someone was accused of such an assault, that they would be removed from the University, before any charges or conviction was brought against them. This is not the case. Action would be taken to separate the Suspect and victim, where possible, alongside the Police investigation.
- The new guidelines that this motions proposes, will be for all Genders and sexualities and not restricted to women, as with the Zellick Report.
- Currently, the University does not act until the Police state that they should or need to.
- As our legal system supports innocent until proven guilty, there were concerns that this will have a negative impact on the suspect and could negatively impact on their university experience, especially if they were not charged. However, suspects' names would not be made public. Both parties will be offered support and the situation will be treated sensitively.
- The Vice Chancellor has many demands on her time. We would not ask her to take a nationwide stance if this would impact her other duties, but feel that this issue goes beyond Lincoln students, and action does need to be taken at a more national level.

Speech against:

• This could set a dangerous precedent. While the need to protect the victim is important, it could have life changing consequences for any suspects, before or even without charges being brought against them.

Point clarification: This would mean the University takes action alongside the police investigation and not instead of. This should reduce negative impact on suspects that are not charged.

No speech to abstain.

Votes: For: 12 Against: 2

Motion passed.

6. Motion to support the action of NUS in regards to the Maintenance grants cuts.

Speech For:

- Presented by Sammi Storey, on behalf of the Exec team.
- We will support NUS in their proposal to lobby the government. Many students will struggle without these grants.
- For those who do not receive the grant, or money from parents, this will give them options for further financial support. Having the repayment threshold frozen is a more significant issue. It was decided that this should be presented as a separate motion.
- Some Political societies may want to have external speakers to help campaign on this, but the external speakers' policy may prevent this.

Point of Information: we cannot support political parties, but as this affects students, we can support students to campaign on this.

Proposed amendment to the motion:

- Proposed By Connor Muir. Seconded by John-Paul Dickie.
- As this will affect every student whether they currently receive the grant or not, this should go to Referendum.

Speech against the amendment:

- This will not have much effect for those students who do not receive the grant.
- This will allow students who do not receive the grant to apply for more money on a loan.

Vote on the amendment:

For: 8 Against: 10 Abstain: 2

Amendment fell.

Speech against the motion:

- The maintenance grant fight has already been fought and lost. We should be trying to lower course costs, accommodation costs etc.
- We are deciding between having a large debt that we cannot pay off, or having a slightly larger debt we will never pay off.
- By scrapping the grant, it may affect those from lower income families. This change from grant to loan will not make a difference as a good job requires a good degree and education.
- We should consider those who do not have supportive families, are reliant on money that they do not need to pay back, and a grant take the pressure off as parents do not want their children to been in a large amount of debt.
- More information should be made available so that people can make an informed decision. Some colleges do not provide all information about financial support before students start to consider Higher Education.

Motion vote: For: 7 Against: 9 Abstain: 4

7. Ratify chair of Students' union Election Question Time.

Discussion Topics:

A review of the Zone Structure.

- Academic Reps are happy with the format.
- Timing is not always ideal for zones. In theory it was a good idea, but in practice it has not worked. The idea was to make it more transparent, but this doesn't appear to be the case.
- It has been useful to prepare for larger meetings in areas, such as societies committee and Rep forum.
- The meetings do not need to be as formal or as often.
- The zones are not essential to hold Reps to account as committees can do this.
- The zones need to be more tailored to each area.
- Budgeting has been confusing between both Zones under the Welfare umbrella.
- There are too may positions and some positions are seen as not relevant and many people do the same job.

How well does Council Function and what Could Be Changed? If it were to be replaced, what would it be replaced with?

- Online forums would be good.
- Officers are good so that people that can ask questions that are more personal and sensitive.
- Many students don't understand how council works and do not understand why some things are voted on the way that they are.
- Council is too structured and some by-laws and rules are seemingly pointless, for example, that all points to a motion have to be questions, some information and detail cannot be added by this method.
- Council is not proportional. College Officers represent different sized groups.
- Council is the only direct point that Students and Reps can hold the Student leaders to account.
